2011 One-Year Action Plan for Community Development Block Grant (CDBG) Funds

STAFF RECOMMENDATION:

It is requested that Council 1.) Adopt Resolution No. 2010-68 approving the submittal of a Civil Society grant proposal to the Escondido Charitable Foundation in the amount of \$25,000; 2.) Authorize staff to receive the grant if awarded; and 3.) Approve a first amendment to the FY 2010-2011 One-Year Action Plan for CDBG allocating \$20,000 in public service funds to use as matching funds for the grant (if awarded).

FISCAL ANALYSIS:

The City of Escondido receives annual formula allocations of CDBG program funding from the U.S. Department of Housing and Urban Development (HUD). All program and program administration expenses are paid with CDBG funds and do not impact the City's general fund.

On March 24, 2010, City Council approved the FY 2010-2011 One-Year Action Plan for CDBG funds based on an estimated allocation of \$1,732,912. On March 30, 2010, the City received its actual CDBG allocation amount of \$1,874,335, which provides an additional \$21,250 in funds that are eligible to use for public service projects. If grant funds are not awarded, the \$20,000 will go into unallocated CDBG funds to be used for future capital projects.

BACKGROUND:

The Escondido Charitable Foundation is in its fourth year of grant making. In the current cycle, covering fiscal year 2010-2011, grants will focus on supporting projects that foster community participation, consensus-building and collective problem solving in the field of children, youth programs and youth education. The grant being applied for is the Foundation's "Civil Society" grant in the amount of \$25,000. Proof of matching funds is recommended for successful grant proposals.

The City of Escondido's grant proposal includes a "Creating Community" project which facilitates training and development for at-risk youth through joint efforts shared by the City's Neighborhood Services Division, Recreation Division, Library, Police Department and the Escondido Education COMPACT. In addition, the Family Intervention Team (F.I.T), a gang prevention/intervention team comprised of collaborative partners, will provide services to identify youth who may be at-risk for

potential gang involvement. The Turning the Hearts Center, which offers programs for at-risk youth, has also pledged to be a partner.

The" Creating Community" project will include 6-8 week sessions throughout the grant cycle offering recreational opportunities to at-risk youth such as sports, dance and aquatics, in addition to educational components covering leadership development, job readiness skills, life skills, anger management, literacy and goal setting.
