SUBJECT: POLICE AND FIRE HEADQUARTERS CHANGE ORDER - BRADY COMPANY

RECOMMENDATION:

It is requested that the City Council approve a construction change order with Brady Company (Bid Package 09A) in the amount of \$20.782.00 for additional work at the Police and Fire Headquarters.

FISCAL ANALYSIS:

Funding will come from the Public Safety Facility Expansion account 229-150179.

CORRELATION TO THE CITY COUNCIL ACTION PLAN:

This item relates to the Infrastructure and Public Facilities element of the 2009-2010 Council Action Plan.

PREVIOUS ACTION:

On March 5, 2008, the City Council accepted the bid of Brady Company in the amount of \$3,733,000 for the construction of Phase IV Bid Package 9A (Finishes, Drywall, Metal Studs, Doors, Frames, and Hardware) for the Police and Fire Headquarters. On March 24, 2010, Council approved a construction change order in the amount of \$34,621.65. On May 5, 2010, Council approved construction change orders in the amount of \$10,610.14.

BACKGROUND:

Approval of the following change orders is required by the City Council since it exceeds the Project Manager's authority to approve:
