SUBJECT: Business Improvement District (BID) Annual Report and Resolution of Intention to Set the Public Hearing Date to Modify the Benefit Zones within the BID Boundary and

to Levy BID Assessments Rates for FY 2010-11

RECOMMENDATION:

It is requested that Council approve the annual BID report as submitted and adopt Resolution 2010-69 to set June 23, 2010 as the public hearing date to modify the benefit zones within the BID boundary and levy the BID assessments for FY 2010-11.

FISCAL ANALYSIS:

There is no fiscal impact to the City of Escondido other than staff time to administer the collection and processing of the payments. Assessments are collected by the Code Enforcement Division's Business License staff and passed through to the Downtown Business Association (DBA).

CORRELATION TO THE CITY COUNCIL ACTION PLAN:

The events, activities and programs carried on within the BID relate to the Council's Action Plan regarding Economic Development.

PREVIOUS ACTION:

Council initially adopted Ordinance No. 89-28 on June 4, 1989, establishing a Downtown Business Improvement (Assessment) District. Resolutions are adopted annually to set the assessment schedules and rates. This is done in accordance with the provisions of the California Streets and Highways Code. The benefit zones within the BID were modified and the rate structure was amended on June 18, 2008 by Resolution 2008-101.

BACKGROUND:

The Streets and Highways Code enables the formation of business improvement districts and Section 36534 requires an annual review of the BID activities and use of the assessments. It also requires that BID assessments be set annually, even if there are no changes to the rates. The Annual BID Report June 9, 2010 Page 2

DBA has submitted the attached report that includes details about events, programs, activities, finances and budget. All businesses located within the BID area are assessed according to the schedule and rates as adopted annually. The assessment is collected when the business license is issued and annually thereafter, when the business license is renewed. The assessments are passed through to the DBA on a monthly basis; the City does not receive any portion of the assessments. The DBA serves as the stewards of the assessment funds and oversees activities and improvements in the BID area. Their responsibilities, and those of the City of Escondido, are detailed in an agreement adopted in November 1990 and amended in 1995 and 2007.

At this time, the DBA will submit their annual report and request that the Council set June 23, 2010 at 4:00 p.m. as the public hearing date and time to modify the assessment zones within the existing BID boundary and to levy assessment rates for FY 2010-11. The rates will be the same as those levied in FY 2009-10. Some minor changes are proposed in the zone boundaries for Zones 1 and 2. The change would reduce the size of Zone 1 by moving the boundary west to the middle of Ivy Street, effectively reducing BID fees for the businesses located on the east side of Ivy Street. The affected businesses would now pay the Zone 2 assessment rate. The DBA's justification for this change is to reflect the reduced benefit experienced by businesses at the east end of the BID.

Council adoption of Resolution 2010-69 will set the public hearing date for the FY 2010-11 assessments. The City Council can preliminarily approve the recommendations as stated in the DBA's attached annual report, or the Council can request that changes be made.

The City Council can receive written protests filed with the City Clerk before the public hearing date of June 23, 2010, or a business owner can speak at the public hearing if they wish to do so. Each written protest shall contain a description of the business in which the person subscribing the protest is interested, sufficient to identify the business. If a person subscribing (filing the written protest) is not shown on the official records of the City as the owner of the business, the protest shall contain or be accompanied by written evidence that the person subscribing is the owner of the business. A written protest which does not comply with this section shall not be counted in determining a majority protest per California Codes (form and manner of protests). Protests can also be made at the public hearing.

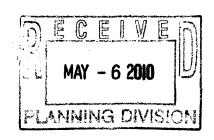

Annual Report of the Downtown Business Improvement District, Pursuant to section 36533 of the California Streets and Highways Code

Enclosed is the 2010-2011 Annual Report of the Downtown Business Improvement District, in its twenty-first year of operation, overseen by the Board of Directors of the Downtown Business Association of Escondido.

There is no increase in fees being proposed.

There is benefit zone change proposed for an E. Grand section of the BID, due to fewer benefits being available there. This benefit zone change will reduce the BID fees of all businesses currently located in that area.

In April the DBA mailed a survey to the 745 BID businesses, requesting their input on how they would like their BID fees to be spent. The DBA Board and staff have incorporated the replies and wishes of the respondents into the BID Activities and Improvements planned for 2010-2011 FY.

2010-2011 ANNUAL REPORT

BUSINESS IMPROVEMENT DISTRICT DOWNTOWN ESCONDIDO

Pursuant to section 36533 of the California Streets and Highways Code

BACKGROUND

On June 14, 1989, under Ordinance #89-28, a Business Improvement District (BID) was formed and, by contractual agreement with the City of Escondido, the DBA was appointed as its advisory board in accordance with California Streets and Highway Section 36500 et seq.

Audit

We have included funding for an audit in our current budget, which will be filed with the City Clerk within 120 days from the end of our fiscal year (October 2010).

New and/or Expanded Programs

1. No changes in Boundaries proposed. (See Map, Attachment "A")

One benefit zone change is being proposed: Change the area (currently benefit zone 1) from the center of Ivy Street to the eastern boundary of the BID, to benefit zone 2. This will result in a reduction in BID fees for those businesses located in that 1-1/2 block area.

2. Improvements and Activities:

BID members are informed of member issues and events via weekly e-mailings. The following is a summary of the events and programs that are currently being organized by DBA with the use of BID funds:

Improvements:

Grand Ave Trash Receptacle Project - maintenance Rooftop Lighting Project - maintenance and expansion Sidewalk Cleaning- Grand Ave area cleaning Beautification - Cleanup and plantings along sidewalks/tree wells Decorations - New Downtown Banners

Activities:

Economic Development of Downtown Escondido

ArtWalk

Holidays Downtown - Annual December activities, promotions and advertising Merchant Meetings - Monthly roundtable meetings of business members

Annual BID Meeting/Neighborhood Block Party

Marketing: Promotion of public events which benefit the businesses in the area, promote tourism, and provide music in a public place

- Weekly email blasts of coming activities, to membership and wider community
- Downtown Magazine expanded distribution of 4,000 copies, promoting BID events (Restaurant Week, Holidays Downtown, Artwalk, Dog-Friendly Business District, Grape Day Park support) and DBA public events (Love of Chocolate, Farmers Market, *Cruisin' Grand*, Taste of Escondido, Ladies on the Loose, Downtown Live)
- Restaurant Week 2 week promotion in May, of Downtown eateries

An annual survey, done in April, is designed to collect member information regarding how they want to see their BID funds allocated. (See Survey Results, Attachment "B")

Updates on where BID fees are being spent and changes and additions of events and programs will continue to be communicated through four publications each year, in an effort to answer commonly expressed concerns and questions.

- 4. BID Events/Programs: The Method and Basis of Levying Assessments, based on "Benefit Zones" (See BID Assessment Formulas, Attachment "D")

BID Fees: No increases in the BID fees are requested.

- 5. The Amount of any Surplus or Deficit Revenues to be Carried Over from Previous Fiscal Year. (See BID Budget, Attachment "C")
- 6. The Amount of Any Contributions to be made from Sources Other Than Assessments Levied Pursuant to This Report. (See BID Budget, Attachment "C")

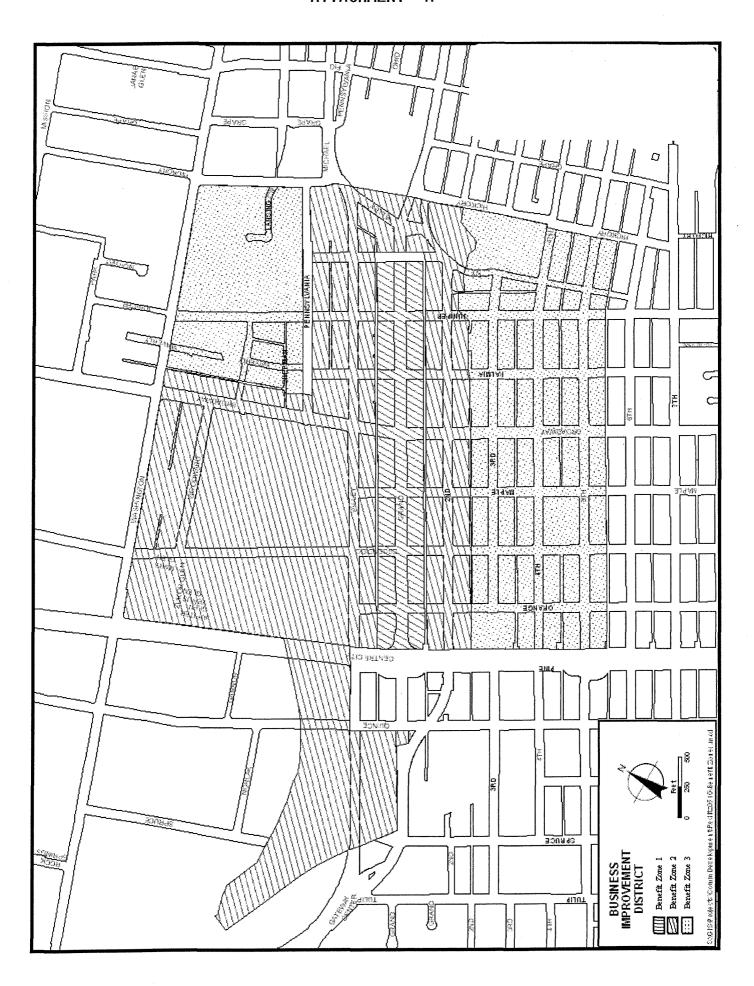

In order to help the DBA Board determine and prioritize the needs of BID members per the approved benefits addressed in the California Streets and Highways Code, the DBA mailed surveys, to all BID members in the Business District. The survey asked "If you had \$100 per year to spend on the following programs, how would you allocate it?" Of the 65 surveys returned, the results are:

32.88%	Clean & Safe	(Sidewalks, Lighting, Trash, Maintenance)
16.83%	Economic Development	(Business Attraction and Retention, Design Assistance)
15.29%	Marketing	(Promoting Downtown as a place to live, work, shop & play; included Restaurant Week, and Downtown Escondido Magazine)
13.71%	Beautification	(Plantings, facades, and projects, Rooftop Lighting)
11.74%	Special Events	(ArtWalk, Holidays Downtown, promotion of events)
9.55%	Parking Issues	(Advocacy and Solutions)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ESCONDIDO, CALIFORNIA, AUTHORIZING THE MAYOR AND CITY CLERK, ON BEHALF OF THE CITY, TO SET A PUBLIC HEARING DATE OF JUNE 23, 2010, AT 4:00 PM TO MODIFY THE BENEFIT ZONES WITHIN THE BUSINESS IMPROVEMENT DISTRICT BOUNDARY AND LEVY DOWNTOWN BID ASSESSMENTS FOR FISCAL YEAR 2010-11

WHEREAS, Ordinance No. 91-37 was adopted on October 2, 1991, by the City Council, authorizing assessments for businesses within the Escondido Downtown Business Improvement District; and

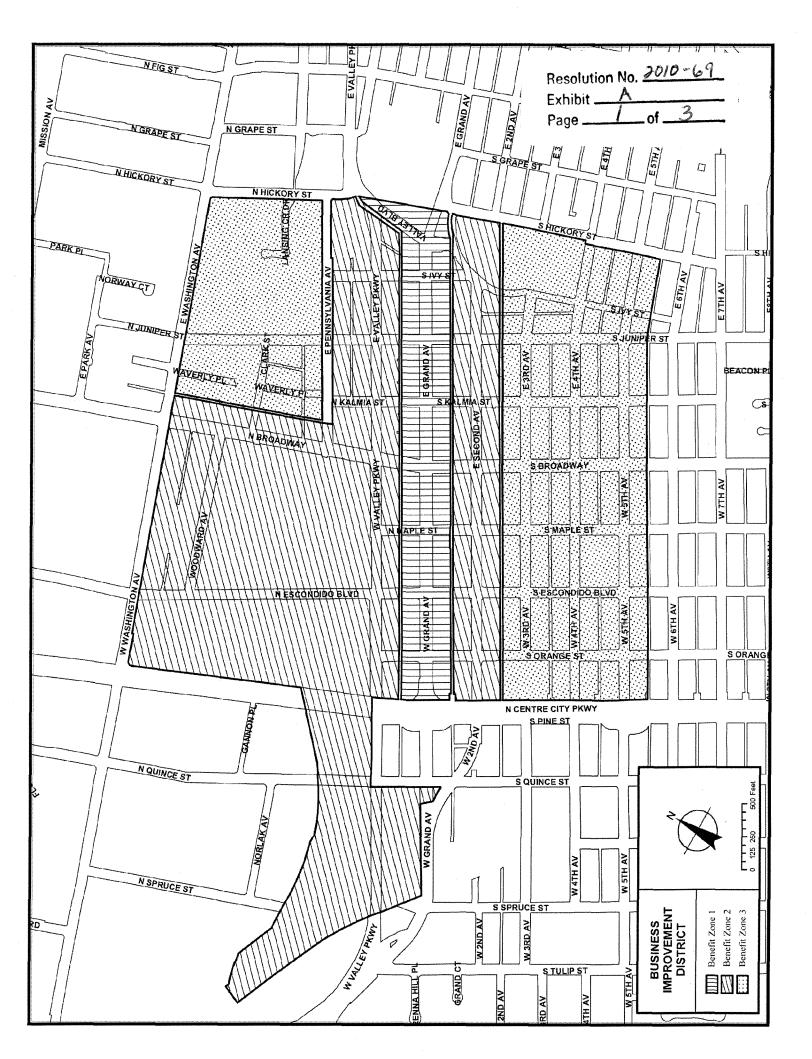
WHEREAS, these assessments are to be used for certain improvements and activities for the benefit of the businesses located within the Business Improvement District; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Escondido, California, as follows:

- 2. That the City Council will consider on June 23, 2010, at 4:00 PM, the following assessment schedule and rates for FY 2010-11, noted in the resolution, for

the businesses within the Escondido Downtown Business Improvement District. The current BID map with benefit zones and assessment rate schedules are attached as "Exhibit A"; the proposed BID map, benefit zones and assessment rate schedules are attached as "Exhibit B", and both Exhibits are incorporated by this reference.

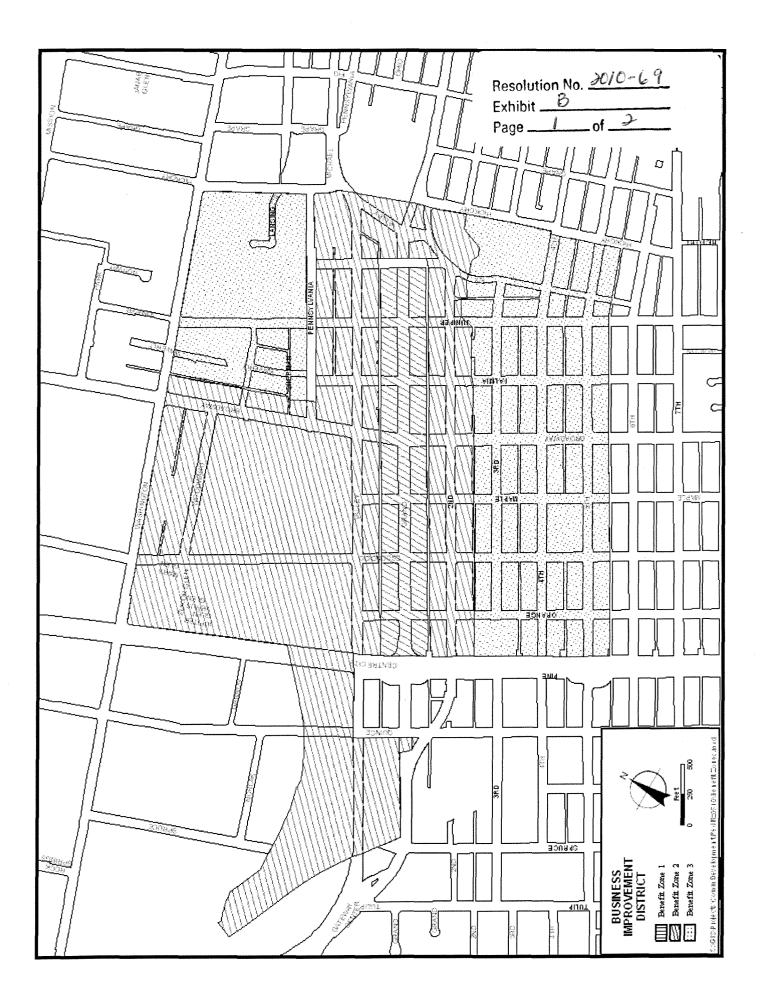
